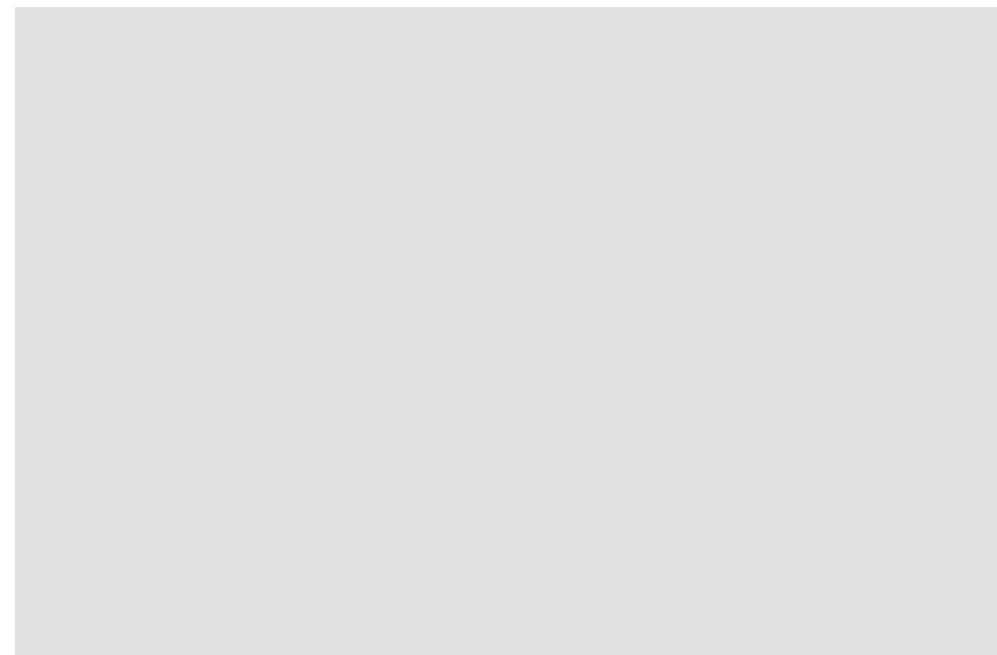

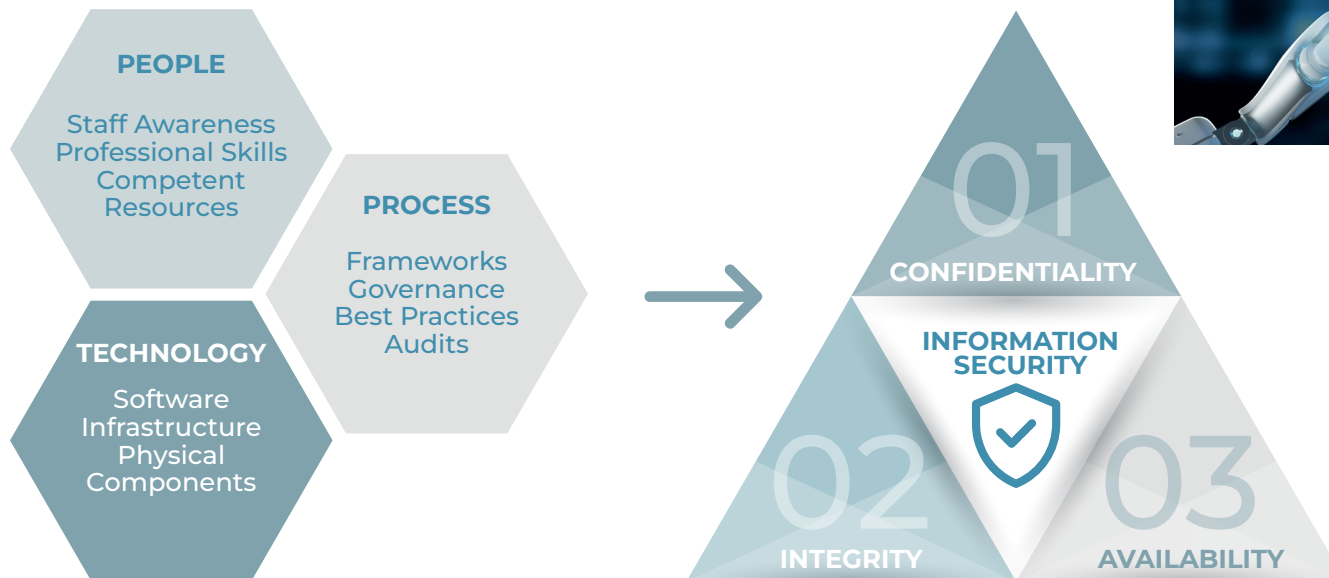

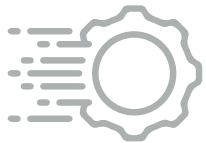
Protection
